2021 Fire Season Wildfire Assistance Application Instructions:

- **Wildfire Assistance Applications are due into the OCA Office by May 31, 2022 with invoices and/or final expenditure receipts due no later than December 1, 2022. Mail to: Oregon Cattlemen's Association, 1320 Capitol St. NE, Suite 150, Salem, OR 97301; fax to: 503-361-8947; or email to: oca@orcattle.com**
- Qualifying Entities or individuals: OCA members and County Associations, Cattle producers, RFPA's, volunteer fire departments or organizations, individuals or others that provided assistance, resources or funds to fight 2021 Wildfires that caused losses or threatened cattle producers livestock, property or resources. Funds were received by OCA as private donations for 2021 Wildfire Assistance (no public funds).
- Assistance applications (with supporting documentation) will be considered for reimbursement of expenses or losses incurred by individuals or entities as a direct result of 2021 wildfires in Oregon counties for claims which have not been or are not expected to be covered by the reimbursement of another program or source such as: Property Insurance or the FSA Emergency Conservation Program (ECP) cost share program.
- Assistance applications will be considered for incurred expenses or losses suffered from: A) Emergency Feed, Transport or Pasturing; B) Fencing Loss; C) Infrastructure Loss; D) Seeding Cost; E) Assistance provided to producers or related wildfire costs; F) Supplies and materials used to be replaced; G) Other losses or expenses as described by applicant.
- The format for reviewing received assistance applications, reviewing applicant's supporting documentation, and issuing disbursements to applicants will be determined by the OCA Wildfire Assistance Committee . This committee will determine if the application meets the program criteria and the amounts, if awarded. The wildfire fund may not be sufficient to meet all requests and may be prorated between applicants at the committee's discretion.
